#### Exciting Announcement!

As you know, in July of 2015 your Suffolk County Deferred Compensation Board made the decision to have all Plan assets managed by one service provider, T. Rowe Price. The Board has negotiated a reduction in the amount charged by T. Rowe Price to administer the Plan and has instructed T. Rowe Price to return those assets to Plan Participants. This money will be deposited into your Deferred Compensation account at T. Rowe Price. You can expect to see your first credit in the third or fourth quarter of 2017 and you will receive a letter containing more details.

While the amount you receive may not be large, the Board felt it was important to return any assets available through negotiations, back to participants.
